

## FAMOUS AMOS™ “GET FAMOUS!” SWEEPSTAKES

### OFFICIAL RULES

#### NO PURCHASE NECESSARY

1. PROMOTION DESCRIPTION: The **Famous Amos™ “Get Famous!” Sweepstakes** consists of a Grand Prize Sweepstakes and a Secondary Prize Sweepstakes (“Secondary Prize Sweepstakes”) (collectively, the “Sweepstakes”). The Sweepstakes begins at 12:00:00 AM Eastern Time (ET) on 2/1/16 and ends at 11:59:59 PM (ET) on 9/30/16 (“Promotion Period”). The Secondary Prize Sweepstakes will consist of three (3) Entry Periods during the Promotion Period (collectively, the “Secondary Prize Sweepstakes Entry Periods”) as further defined below. Secondary Prize Sweepstakes entries received during the Promotion Period will be automatically entered into the Grand Prize Sweepstakes. For purposes of these Official Rules, a “Day” is defined as each twenty-four (24) hour period during the Promotion Period beginning at 12:00:00 AM (ET) and ending at 11:59:59 PM (ET). **Non-winning Secondary Prize Sweepstakes entries will be automatically rolled over into subsequent Secondary Prize Sweepstakes drawings.**
2. ELIGIBILITY: Open to legal residents of the fifty (50) United States and the District of Columbia who are 18 years of age or older. Employees of Kellogg Company (“Sponsor”), Fandango Loyalty Solutions, LLC, and their respective parent companies, affiliates, subsidiaries, suppliers, advertising and promotion agencies and anyone else connected with the production and distribution of this Sweepstakes (collectively, the “Promotion Entities”) and their immediate family members (spouse, parent, child, sibling and their respective spouses, regardless of where they reside) and/or those living in the same household of each are not eligible to participate.   - A) **KFR Entry:** You will receive one (1) entry into the Sweepstakes for each **Famous Amos®** Participating Product purchase (“Proof of Purchase Transaction”) when you enter through KFR. For this Sweepstakes, “Participating Products” include - **Famous Amos® Chocolate Chip cookies** (12.4 oz.); **Famous Amos® Chocolate Chip Pecan cookies** (12.4 oz.); **Famous Amos® Chocolate Chip cookies bag** (8 oz.); **Famous Amos® Chocolate Chip cookies multi-pack** (14.4 oz.); and **Famous Amos® Double**

**Chocolate Chip cookies** (12.4 oz.). A Proof of Purchase Transaction can occur in two (2) ways:

1) By purchasing one (1) or more of the Participating Products and uploading the receipt(s) to [www.kfr.com/GetFamous](http://www.kfr.com/GetFamous) (“KFR Entry Website”) or by texting an image of the receipt from your mobile device to 89332. **NOTE:** In order to submit a Proof of Purchase Transaction via the text entry method, you must first opt-in to receive SMS messages from the Sponsor. To opt-in, log-in to [www.KFR.com](http://www.KFR.com); go to MyAccount; then go to your Profile; while in your Profile (**note:** be sure you have a mobile number included in your profile); go to Subscriptions and check the “SMS” box. Uploads must be completed within fourteen (14) days of purchase of a Participating Product into order to process to be completed. For text entry - After sending your text entry, you may receive one (1) or more text messages in response to your text entry, including a message confirming your entry, and legal disclaimers from Sponsor. By texting the Sponsor, you agree to receive automated text messages by or on behalf of Kellogg Company and Fandango regarding the Sweepstakes. Consent not required for purchase. If you do not want to opt-in to receive any such text messages or wish to enter without making a purchase, then you should enter the Sweepstakes using the No Purchase Entry option below (rule 3B). You may opt-out of receiving the promotional text messages from Sponsor at any time by sending a reply text message with the word “STOP”. 2) By linking qualifying retailer loyalty cards to your KFR account and purchasing one (1) or more Participating Products at that retailer.

All Proof of Purchase Transactions must be made in compliance with the KFR Terms (see rule #1), during the Promotion Period. The entry will be entered into the Grand

Prize Sweepstakes; and the Secondary Prize Sweepstakes corresponding to the entry period in which the Proof of Purchase Transaction is received

liability for any winner notification that is lost, intercepted or not received by a potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond within forty-eight (48) hours of the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner will forfeit his or her prize and an alternate winner may be randomly selected in Sponsor's sole discretion. Sponsor, in its sole discretion, will attempt to contact up to three (3) alternate potential winners of a prize in accordance with the above procedure, after which the prize in question may go unawarded if it remains unclaimed. If, despite reasonable efforts, a potential winner does not respond within five (5) calendar days of the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner will forfeit his or her prize and an alternate winner may be randomly selected in Sponsor's sole discretion. Sponsor, in its sole discretion, will attempt to contact up to three (3) potential winners of a prize in accordance with the above procedure, after which the prize in question may go unawarded if it remains unclaimed. If any potential prize winner is found to be ineligible, or if he or she has not complied with these Official Rules or declines the prize for any reason prior to award, such prize will be forfeited and an alternate prize winner may be selected
