OFFICIAL RULES

NO PURCHASE NECESSARY

1. PROMOTION DESCRIPTION: The **Kellogg's™ Bowl Season's Official Snack Sweepstakes** ("Sweepstakes") begins at 12:00:00 AM Eastern Time (ET) on 11/16/21 and ends at 11:59:59 PM (ET) on 7/4/22 ("Promotion Period"). Sweepstakes entry will be available via the digital receipt upload of a purchase of a Participating Product at the promotion website and at Twitter.com (the "**Social Platform**"), as further defined below. For purposes of these Official Rules, a "Day" is defined as each twenty-four (24) hour period during the Promotion Period beginning at 12:00:00 AM (ET) and ending at 11:59:59 PM (ET). At the conclusion of the Promotion Period, one (1) Grand Prize winner plus all eligible entrants will receive one (1) 25% off offer at Fanatics.com, as more fully described below.
 2. ELIGIBILITY: Open to legal residents of the fifty (50) United States and District of Columbia who are 18 years of age or older at the time of entry. Employees of Kellogg Company ("**Sponsor**"), its parent company, affiliates, subsidiaries, suppliers, advertising and promotion agencies and anyone else connected with the production and distribution of this Sweepstakes (collectively, the "**Promotion Entities**") and their immediate family members (spouse, parent, child, sibling and their respective spouses, regardless of where they reside) and/or those living in the same household of each are not eligible to participate. 2. **TAKE A PIC** of your receipt showing the Qualifying Purchase.
3. **UPLOAD** the receipt to www.KFR.com/bowlinsnack. Uploads must be completed within thirty (30) days of purchase of a Participating Product in order for process to be completed; upload must be completed no later than 8/3/22. Only a Qualifying Purchase of a Participating Product is valid for an entry via the KFR method of entry. Photo must include the entire receipt from top to bottom, including all four (4) corners. Be sure that the store name, date, bar code (if available), items and prices are legible in your image(s). Blurry and/or unreadable receipt images will be rejected. Entry by making a purchase of a Participating Product and uploading a receipt to the Website will not improve your chance of winning. B) **No Purchase Entry:** You must be a registered member of Twitter.com (the “**Social Platform**”) with an account set to public to enter via this method of entry. Limit of five (5) entries per person, per day – regardless of method of entry.

NOTE: Entries must be made solely by the entrant. Entries made by any other individual or any entity, and/or originating at any other website or e-mail address, including but not limited to commercial sweepstakes subscription notification and/or entering service sites, will be declared invalid and disqualified for this Sweepstakes. 5. **WINNER SELECTION AND NOTIFICATION:** Grand Pinner will be selected in a random drawing on or about 8/5/22 from among all eligible entries received by Sponsor or its designee, whose decisions are final and binding, during the respective Entry Period. The potential prize winners will be notified by email (for Website entries) or Twitter Direct Message ("**DM**") (for Twitter entries), phone and/or mail, using contact information provided or collected at the time of entry. Sponsor shall have no liability for any winner notification that is lost, intercepted or not received by a potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond within five (5) calendar days of the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner will forfeit his or her prize and an alternate winner may be randomly selected in Sponsor's sole discretion. Grand Prize winner will receive a 3-day/2-night trip for winner and one (1) guest to attend the 2023 College Football Playoff National Championship Game in Inglewood, California (ARV \$4,000). Prize includes: round-trip coach air transportation for winner and one (1) guests between a major commercial airport closest to the winner's primary U.S. residence (as selected by Sponsor in its sole

discretion) and Los Angeles, CA; standard double-occupancy hotel accommodations consisting of one (1) room for two (2) nights; and admission for winner and his/her guest to the 2023 College Football Playoff National Championship Game scheduled to be held on 1/9/23. **Trip must be taken from 1/8/23 through 1/10/23 or prize will be forfeited in its entirety.**
