

KELLOGG'S™ BOWL SEASON'S OFFICIAL SNACK SWEEPSTAKES**OFFICIAL RULES****NO PURCHASE NECESSARY**

1. **PROMOTION DESCRIPTION:** The **Kellogg's™ Bowl Season's Official Snack Sweepstakes** (“Sweepstakes”) begins at 12:00:00 AM Eastern Time (ET) on 11/14/19 and ends at 11:59:59 PM (ET) on 7/31/20 (“Promotion Period”). Sweepstakes entry will be available via the digital receipt upload of a purchase of a Participating Product at the promotion website and at Twitter.com (the “Social Platform”), as further defined below. For purposes of these Official Rules, a “Day” is defined as each twenty-four (24) hour period during the Promotion Period beginning at 12:00:00 AM (ET) and ending at 11:59:59 PM (ET). At the conclusion of the Promotion Period, one (1) Grand Prize winner and three (3) First Prize winners will be randomly selected, as more fully described below.
 2. **ELIGIBILITY:** Open to legal residents of the fifty (50) United States and District of Columbia who are 18 years of age or older at the time of entry. Employees of Kellogg Company (“Sponsor”), its parent company, affiliates, subsidiaries, suppliers, advertising and promotion agencies and anyone else connected with the production and distribution of this Sweepstakes (collectively, the “Promotion Entities”) and their immediate family members (spouse, parent, child, sibling and their respective spouses, regardless of where they reside) and/or those living in the same household of each are not eligible to participate. Void where prohibited.
 3. **HOW TO ENTER THE SWEEPSTAKES:** There are two (2) methods of entry. In order to enter the Sweepstakes via entry method 3A noted below, you must be a registered member of the **Kellogg's Family Rewards®** (“KFR”) program. To become a registered member of the KFR program, go to www.KFR.com/bowl snack (“Website”) and follow the instructions to complete the registration. Becoming a KFR program member and entry into the Sweepstakes is free. By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Sponsor, which shall be final and binding in all respects. - A) **KFR Entry:**
1. **BUY** one (1) or more of any of the following Participating Products - **Cheez-It® Original** crackers (7 oz., 12.4 oz., 21 oz.); **Cheez-It® White Cheddar** crackers (7 oz., 12.4 oz.); **Cheez-It® Extra Toasty** crackers (12.4 oz.); **Cheez-It® Snack Mix Original** (10.5 oz.); **Cheez-It Grooves™** crackers (9 oz. – Sharp White Cheddar) (“Participating Products”) during the Promotion Period (“Qualifying Purchase”).
 2. **TAKE A PIC** of your receipt showing the Qualifying Purchase.

3. **UPLOAD** the receipt to www.KFR.com/bowlsnack. Uploads must be completed within fourteen (14) days of purchase of a Participating Product in order for process to be completed; upload must be completed no later than 8/14/20. Only a Qualifying Purchase of a Participating Product is valid for an entry via the KFR method of entry. Photo must include the entire receipt from top to bottom, including all four (4) corners. Be sure that the store name, date, bar code (if available), items and prices are legible in your image(s). Blurry and/or unreadable receipt images will be rejected. For help or more information, visit www.KFR.com/bowlsnack. If you wish to enter without making a purchase, then you should enter the Sweepstakes using the No Purchase Entry option below. Entry by making a purchase of a Participating Product and uploading a receipt to the Website will not improve your chance of winning. Proof of uploading an image of a receipt at the Website is not considered proof of delivery to or receipt by Sponsor of such Sweepstakes entry.

B) **No Purchase Entry:** You must be a registered member of Twitter.com (the “**Social Platform**”) with an account set to public to enter via this method of entry. To become a registered Twitter user, go to www.Twitter.com and follow the instructions to become a user. Becoming a registered Twitter user and entry into the Sweepstakes is free, but is subject to acceptance of the terms and conditions of use of www.Twitter.com. To enter via the No Purchase Necessary method, go to Twitter.com, log into your Twitter account and tweet the hashtag **#BowlSnackEntry** (the “**Hashtag**”). All Social Platform tweets must be completed from a non-private Social Platform account and must include the Hashtag. By using the Hashtag, you affirm that you have read, understand and agree to these Official Rules. Sweepstakes is in no way sponsored, endorsed or administered by Twitter. **Direct any questions, comments, or complaints regarding the Sweepstakes to Sponsor, not Twitter.**

Limit of five (5) KFR entries and five (5) Twitter entries per person, per day.

NOTE: Entries must be made solely by the entrant. Entries made by any other individual or any entity, and/or originating at any other website or e-mail address, including but not limited to commercial sweepstakes subscription notification and/or entering service sites, will be declared invalid and disqualified for this Sweepstakes. The use of any device to automate the entry process is prohibited. Sponsor is not responsible for any change of email address, mailing address and/or phone number of entrants.

The Website’s database clock will be the official timekeeper for online entries in this Sweepstakes. In the event a dispute regarding the identity of the individual who actually submitted an entry cannot be resolved to Sponsor’s satisfaction, the affected entry will be deemed ineligible. Promotion Entities shall not be responsible for incorrect or inaccurate entry information whether caused by Internet users or by any of the equipment or programming associated with or utilized in the Sweepstakes or by any technical or human error which may occur in the processing of the entries in the Sweepstakes. 4. **WINNER SELECTION AND NOTIFICATION:** Winners will be selected in a random drawing on or about 8/17/20 from among all eligible entries received by Sponsor or its designee, whose decisions are final and binding, during the respective Entry Period. The potential prize winners will be notified by email (for Website entries) or Twitter Direct Message ("**DM**") (for Twitter entries), phone and/or mail, using contact information provided or collected at the time of entry. Sponsor shall have no liability for any winner notification that is lost, intercepted or not received by a potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond within five (5) calendar days of the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner will forfeit his or her prize and an alternate winner may be randomly selected in Sponsor's sole discretion. Sponsor, in its sole discretion, will attempt to contact up to three (3) potential winners of a prize in accordance with the above procedure, after which the prize in question may go unawarded if it remains unclaimed. If any potential prize winner is found to be ineligible, or if he or she has not complied with these Official Rules or declines the prize for any reason prior to award, such prize will be forfeited and an alternate prize winner may be selected.

5. **PRIZES/APPROXIMATE RETAIL VALUES (ARV)/ODDS:**

One (1) Grand Prize is available. Grand Prize winner will receive a 3-day/2-night trip for winner and one (1) guest to attend the 2021 College Football Playoff National Championship Game in Miami, FL (ARV \$4,000). Prize includes: round-trip coach air transportation for winner and one (1) guests between a major commercial airport closest to the winner's primary U.S. residence (as selected by Sponsor in its sole discretion) and Miami, FL; standard double-occupancy hotel accommodations consisting of one (1) room

for two (2) nights; and admission for winner and his/her guest to the 2021 College Football Playoff National Championship Game scheduled to be held on 1/11/21. **Trip must be taken from 1/10/21 through 1/12/21 or prize will be forfeited in its entirety.**

Three (3) First Prizes are available. Each First Prize winner will receive his/her choice of a 3-day/2-night trip for winner and one (1) guest to attend one (1) of the following 2020 - 2021 College Football Playoff Games, as follows – Cheez-It Bowl (12/26/20 in Phoenix, AZ); Rose Bowl (1/1/21 in Pasadena, CA); Fiesta Bowl (1/2/21 in Glendale, AZ); Cotton Bowl (12/30/20 in Arlington, TX); Peach Bowl (1/1/21 in Atlanta, GA); or Sugar Bowl (1/1/21 in New Orleans, LA) (ARV \$4,000 ea. winner). Selected trip must be taken on dates corresponding to the selected bowl game, to be specified by Sponsor. **Selected trip must be taken on the dates specified by Sponsor or prize will be forfeited in its entirety.**

Seat locations at the designated game shall be determined in the sole discretion of Sponsor. The terms and conditions of the tickets awarded as part of any prize may govern in the event a legal game, event or exhibition, as defined by the applicable governing authority, is not played or held due to weather conditions, an act of God, an act of terrorism, civil disturbance or any other reason. Each winner and his/her guest agree to comply with all applicable stadium and venue regulations in connection with the prize. Sponsor and the applicable venue entities reserve the right to remove or to deny entry to any winner and/or his/her guest who engage(s) in a non-sportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person at the game. Promotion Entities will not be responsible for weather conditions, Acts of God, acts of terrorism, civil disturbances, work stoppage or any other natural disaster outside their control that may cause the cancellation or postponement of any game associated with a prize in this Sweepstakes.
