

2018 CELEBRITY CRUNCH CLASSIC SWEEPSTAKES

OFFICIAL RULES

NO PURCHASE NECESSARY

1. **PROMOTION DESCRIPTION:** The **2018 Celebrity Crunch Classic Sweepstakes** consists of a Grand Prize Sweepstakes (“**Grand Prize Sweepstakes**”) and a First Prize Sweepstakes (“**First Prize Sweepstakes**”) (collectively, the “**Sweepstakes**”). The Grand Prize Sweepstakes begins at 12:00:00 PM Eastern Time (“**ET**”) on 12/18/17 and ends at 11:59:59 AM (ET) on 3/2/18 (“**Grand Prize Sweepstakes Entry Period**”) for all methods of entry. The First Prize Sweepstakes is a Weekly Sweepstakes that begins at 12:00:00 PM (ET) on 12/18/17 and ends at 11:59:59 AM (ET) on 10/31/18 for all methods of entry (the “**First Prize Sweepstakes Entry Period**”). Sweepstakes entry will be available via the Twitter.com (the “**Social Platform**”) or at www.CelebrityCrunchClassic.com (the “**Website**”). Entries received after the expiration of the Grand Prize Sweepstakes Entry will not be included as entries into the Grand Prize Sweepstakes. The Grand Prize Sweepstakes Entry Period and the First Prize Sweepstakes Entry Period are collectively known as the “Promotion Period”. For purposes of these Official Rules, a “Day” is defined as each twenty-four (24) hour period during the Promotion Period beginning at 12:00:00 PM (ET) and ending at 11:59:59 AM (ET); and a “Week” is defined as a seven (7) calendar day period during the Promotion Period beginning on a Monday at 12:00:00 PM (ET) and ending seven (7) days later on a Sunday at 11:59:59 AM (ET) (except the last Week of the Promotion Period that will cover a nine (9) day period beginning on Monday and ending eight (8) days later on Tuesday). **Non-winning First Prize Sweepstakes entries will be automatically rolled over into subsequent First Prize Sweepstakes drawings. Additionally, all eligible First Prize Sweepstakes entries received during the Grand Prize Sweepstakes Period will be automatically entered into the Grand Prize Sweepstakes drawing.**
2. **ELIGIBILITY:** Open to legal residents of the fifty (50) United States and District of Columbia who are 18 years of age or older at the time of entry. Employees of Kellogg Company (“Sponsor”), its parent company, affiliates, subsidiaries, suppliers, advertising and promotion agencies and anyone else connected with the production and distribution of this Sweepstakes (collectively, the “Promotion Entities”) and their immediate family members (spouse, parent, child, sibling and their respective spouses, regardless of where they reside) and/or those living in the same household of each are not eligible to participate. Void where prohibited.
3. **HOW TO ENTER THE SWEEPSTAKES:** There are two (2) methods of entry.
 - A) **Social Media.** To enter the Sweepstakes via Twitter.com (the “Social Platform”), you must be a registered member of the Social Platform with an account set to public. Becoming a member of the Social Platform and entry into the Sweepstakes are both free. Entrants must go to Twitter.com, log into their account and tweet the hashtag **#CrunchClassicEntry** (the “Hashtag”). All Social Platform posts must be posted to a non-private Social Platform account and must include the Hashtag. By using the

Hashtag, you affirm that you have read, understand and agree to these Official Rules. **Direct any questions, comments, or complaints regarding the Sweepstakes to Sponsor, not Twitter.**

- B) Website. To enter the Sweepstakes via the Website method of entry, go to www.CelebrityCrunchClassic.com and complete the online registration with the information requested, and then follow the instructions to complete your entry. Registration is free. Entrants are responsible for insuring that all contact information is up-to-date and accurate.

Limit of (ten) (10) entries per person, per Day during the Promotion Period – regardless of method of entry.

ALL ELIGIBLE SWEEPSTAKES ENTRIES RECEIVED DURING THE GRAND PRIZE SWEEPSTAKES PERIOD WILL BE ENTERED INTO THE GRAND PRIZE SWEEPSTAKES DRAWING. ALL ELIGIBLE SWEEPSTAKES ENTRIES RECEIVED DURING THE FIRST PRIZE SWEEPSTAKES PERIOD WILL BE ENTERED INTO THE RESPECTIVE FIRST PRIZE SWEEPSTAKES DRAWINGS. ADDITIONALLY, ALL ELIGIBLE FIRST PRIZE SWEEPSTAKES ENTRIES RECEIVE DURING THE GRAND PRIZE SWEEPSTAKES PERIOD WILL BE AUTOMATICALLY ENTERED INTO THE GRAND PRIZE SWEEPSTAKES. Submissions may not disparage or denigrate the name, image and/or logo of any school, team, coach, player, celebrity and/or any other individual. If for any reason during the Promotion Period a submission is not compliant with these Official Rules as solely determined by Sponsor, the submission will be disqualified from the Sweepstakes. Submissions must not infringe on any third party rights, including but not limited to intellectual property rights, trademarked property and/or images of companies other than the Sponsor, and the rights of privacy and publicity, and may not include content which is offensive, violent or suggests violence, must not be derogatory, sexually suggestive, obscene, defamatory, contain explicit language or imagery or otherwise be inappropriate for publication in general circulation, or depicts the Promotion Entities and/or any of their products in a manner which is not consistent with its positive image and/or their approved trademark use. No other manufacturers' products are permitted in the submission. By entering the Sweepstakes, the entrant gives Sponsor the right to use, edit, or publish the submission without further compensation and entrant agrees to assign and transfer any and all rights, title and interest in the submission to the Sponsor, and, if required, will sign any documents necessary to transfer copyright and rights of publicity. All entry materials become the property of Sponsor and will not be returned.

NOTE: Entries must be made solely by the entrant. Entries made by any other individual or any entity, and/or originating at any other website, e-mail address, or Social Platform account, including but not limited to commercial sweepstakes subscription notification and/or entering service sites, will be declared invalid and disqualified for this Sweepstakes. The use of any device to automate the entry process is prohibited. Sponsor is not responsible for any change of email address, mailing address and/or phone number of entrants.

The Website's database clock will be the official timekeeper for online entries in this Sweepstakes. In the event a dispute regarding the identity of the individual who actually submitted an entry cannot be resolved to Sponsor's satisfaction, the affected entry will be deemed ineligible. Promotion Entities shall not be responsible for incorrect or inaccurate entry information whether caused by Internet users or by any of the equipment or programming associated with or utilized in the Sweepstakes or by any technical or human error which may occur in the processing of the entries in the Sweepstakes. Promotion Entities assume no responsibility or liability for any error, omission, interruption, deletion, theft or destruction, or unauthorized access to, or alteration of entries.

In the event of a dispute regarding entries, any entries will be deemed to have been submitted by the Authorized Account Holder of the Social Platform account and/or email address submitted at the time of entry, provided that person meets all eligibility requirements set forth in these Official Rules. "Authorized Account Holder" means the natural person who is assigned to an account by Social Platform access provider, Internet access provider, online service provider, or other organization that is responsible for assigning Social Platform accounts or e-mail addresses for the domain associated with the submitted Social Platform account or e-mail address. Entrants may not participate with multiple Social Platform accounts of the same platform, and/or email addresses nor may entrants use any device or artifice to enter as multiple entrants in the Sweepstakes. Any entrant who attempts to enter with multiple Social Platform accounts in the same platform, and/or multiple email addresses, under multiple identities or uses any other device or artifice to enter multiple times beyond the entry limitation stated above will be disqualified from participation and all entries submitted by that entrant will be void. Only fully completed entries are eligible. Proof of submission will not be deemed to be proof of receipt by Sponsor. Sponsor is not responsible for any change of mailing address, email address, and/or telephone number of entrants. The Promotion Entities assume no responsibility or liability for any error, omission, interruption, deletion, theft or destruction, or unauthorized access to, or alteration of entries.

4. **GRAND PRIZE WINNER SELECTION AND NOTIFICATION:** Grand Prize winners will be selected in a random drawing on or about 3/5/18 from among all eligible entries received by Sponsor or its designee, whose decisions are final and binding. The potential Grand Prize winners will initially be notified by email (for Website entrants), or via Direct Message ("DM") from the Sponsor (for Social Platform entrants). Sponsor shall have no liability for any winner notification that is lost, intercepted or not received by a potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond within forty-eight (48) hours of the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such

potential winner will forfeit his or her prize and an alternate winner may be randomly selected in Sponsor’s sole discretion. Sponsor, in its sole discretion, will attempt to contact up to two (2) alternate potential winners of a prize in accordance with the above procedure, after which the prize in question may go unawarded if it remains unclaimed. If any potential prize winner is found to be ineligible, or if he or she has not complied with these Official Rules or declines the prize for any reason prior to award, such prize will be forfeited and an alternate prize winner may be selected provided there is sufficient time remaining to award the prize.

5. **FIRST PRIZE WINNER SELECTION AND NOTIFICATION:** First Prize winners will be selected and awarded based on the following schedule:

Five (5) First Prize Sweepstakes winners each Week of First Prize Entry Period #1 and four (4) First Prize Sweepstakes winners each Week of First Prize Entry Period #2, for a total of two hundred (200) First Prize Sweepstakes winners, will be selected in a random drawing on or about two (2) business days following the end of each Week during the Promotion Period from among all eligible entries received by Sponsor or its designee, whose decisions are final and binding, during the respective First Prize Sweepstakes Entry Period. The potential First Prize Sweepstakes winners will be notified initially by email (for Website entrants) or DM (for Social Platform entrants). Sponsor shall have no liability for any winner notification that is lost, intercepted or not received by a potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond within five (5) calendar days of the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner will forfeit his or her prize and an alternate winner may be randomly selected in Sponsor’s sole discretion. Sponsor, in its sole discretion, will attempt to contact up to two (2) potential winners of a prize in accordance with the above procedure, after which the prize in question may go unawarded if it remains unclaimed. If any potential prize winner is found to be ineligible, or if he or she has not complied with these Official Rules or declines the prize for any reason prior to award, such prize will be forfeited and an alternate prize winner may be selected

6. **PRIZES/APPROXIMATE RETAIL VALUES (ARV)/ODDS: GRAND PRIZE SWEEPSTAKES - Five (5) Grand Prizes** – Each winner will receive a 5-day/4-night trip for winner and one (1) guest to play in a Fantasy Basketball Game in San Antonio, TX with select former college players, coaches and/or celebrities (ARV \$6,500 for each Grand Prize). Each trip includes: round-trip coach air transportation for winner and one (1) guest between a major commercial airport closest to the winner's primary U.S. residence (as selected by Sponsor in its sole discretion) and San Antonio, TX; standard double-occupancy hotel accommodations consisting of one (1) room for four (4) nights; the opportunity for winner and his/her guest to play in a Fantasy Basketball Game on 3/31/18 on a team consisting of Sponsor-selected former college players, coaches and/or celebrities. **Trip must be taken from 3/30/18 through 4/3/18 or prize will be forfeited in its entirety.** No transfer or substitution of trip elements will be permitted. Winner and his/her travel companion must depart/return from the same major airport and travel on

same itinerary. Trip does not include taxes, meals, tips, gratuities, service charges, hotel room service, laundry service, alcoholic beverages, merchandise, souvenirs, local and long distance telephone calls, airport charges, or any other service or item not specifically described above. Trip is not redeemable for cash. Actual retail value of prize may vary depending on location of winner's residence and may fluctuate due to market conditions, changes in value of components, (e.g. air transportation and hotel rates) and other reasons. If winner lives within two hundred fifty (250) miles of San Antonio, TX, Sponsor will substitute air transportation with ground transportation between winner's residence and hotel in the destination city, and the difference in value will not be awarded. In the event any scheduled event associated with the prize and/or any other component of the prize is cancelled, delayed, or postponed for any reason outside the control of the Sponsor, Sponsor will have no further obligation, other than to award the remainder of the prize. Odds of winning a Grand Prize depend on the total number of eligible entries received from all entry methods combined during the Grand Prize Sweepstakes Entry Period. FIRST PRIZE SWEEPSTAKES – Two Hundred (200) First Prizes (see chart in rule 5 for Prize distribution) – A \$100 Fanatics Cash Gift Certificate, ARV \$100 for each First Prize. Gift certificate is subject to terms, restrictions and conditions as designated by issuer. Odds of winning a First Prize depend on the total number of eligible entries received from all entry methods combined for each Week of the respective First Prize Sweepstakes Entry Period. Total ARV of all prizes \$52,500. Unclaimed prizes will not be awarded. All applicable federal, state, and local taxes on prizes are the sole responsibility of the prize winners. Limit one (1) Grand Prize and one (1) First Prize per person in the Sweepstakes. **Grand Prize winners will receive an Internal Revenue Service Form 1099 for the ARV of the prize for the tax year in which the prize was awarded.**

If prize notification or prize is returned as non-deliverable, prize may be forfeited and an alternate winner may be selected. No correspondence will be acknowledged. Subject to all federal, state and local laws/regulations. Sponsor reserves the right to modify, extend, suspend, or terminate the Sweepstakes if it determines, in its sole discretion, that the Sweepstakes is technically impaired or corrupted or that fraud or technical problems, failures or malfunctions or other causes beyond Sponsor's control have destroyed or severely undermined or to any degree impaired the integrity, administration, security, proper play and/or feasibility of the Sweepstakes as contemplated herein.
