

**KELLOGG'S™ CHEEZ-IT™ & PRINGLES™ CELEBRITY CRUNCH CLASSIC
BASKETBALL GAME SWEEPSTAKES**

OFFICIAL RULES

NO PURCHASE NECESSARY

1. **PROMOTION DESCRIPTION:** The ***Kellogg's™ Cheez-It™ & Pringles™*** **Celebrity Crunch Classic Basketball Game Sweepstakes** ("Sweepstakes") is an on-site event Sweepstakes that will be held on 4/2/17 beginning at 11:30 AM Mountain Time (MT) and ending at or about 11:59 AM (MT) ("Promotion Period"). The ***Kellogg's™ Cheez-It™ & Pringles™*** **Celebrity Crunch Classic Basketball Game** and the Sweepstakes will be held at the Chaparral High School in Scottsdale, AZ (collectively, the "Event").
2. **ELIGIBILITY:** Open to legal residents of the fifty (50) United States and District of Columbia who are 18 years of age or older at the time of entry and are in attendance at the Event during the Promotion Period. Employees of Kellogg Company ("Sponsor"), IMG, their respective parent companies, affiliates, subsidiaries, suppliers, advertising and promotion agencies and anyone else connected with the production and distribution of this Sweepstakes (collectively, the "Promotion Entities") and their immediate family members (spouse, parent, child, sibling and their respective spouses, regardless of where they reside) and/or those living in the same household of each are not eligible to participate. The Promotion Entities assume no responsibility or liability for any error, omission, interruption, deletion, or unauthorized access to, or alteration of entries.
4. **WINNER SELECTION AND NOTIFICATION:** Grand Prize winner will be selected in a random drawing based on section number, row number and seat number of all occupied seats or via a random selection process using occupied-seats at the Event just prior to tip-off of the Event from among all eligible entries in attendance at the Event. Decisions of Sponsor are final and binding regarding the Sweepstakes. The potential Grand Prize winner will be announced via the Event Site Public Address system. Sponsor shall have no liability for any winner notification that is lost, unintelligible or not received by a potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond within two (2) minutes of the winner announcement, or if the prize is unable to be awarded due to ineligibility by the potential winner, such potential winner will forfeit his or her prize and an alternate winner will be randomly selected and announced using the process described above. The winner selection and announcement process will be repeated until an eligible winner is confirmed. If any potential prize winner is found to be ineligible, or if he or she has not complied with these Official Rules or declines the prize for any reason prior to awarding the prize, such prize will be forfeited and an alternate prize winner will be selected and announced using the process described above.

PRIZE/APPROXIMATE RETAIL VALUE (ARV)/ODDS: One (1) Grand Prize – Winner will receive the opportunity to play in a Fantasy Basketball Game on 4/2/17 on a team consisting of Sponsor-selected college players, coaches and/or celebrities (ARV \$100). Prize includes a game jersey (to be provided at the Event). **Note: Participation as a player is physical in nature; winner must be able to engage in a moderate to high level of physical activity associated with playing in a basketball game. Additionally, winner must be wearing athletic footwear that is deemed acceptable for participation in the event, in the Sponsor’s sole discretion.** In the event the selected winner is not wearing acceptable athletic footwear, he/she may choose one (1) of the following prize alternatives: a) transfer the opportunity to play in the Fantasy Basketball Game to a friend or relative that is also in attendance at the event and is wearing acceptable athletic footwear; or b) assist in coaching one of the Fantasy teams from the bench (winner would still receive game jersey with this option).
