

## **KELLOGG'S FAMILY REWARDS® - JURASSIC WORLD: FALLEN KINGDOM MOVIE TICKET SWEEPSTAKES**

### OFFICIAL RULES

**NO PURCHASE NECESSARY OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.**

1. PROMOTION DESCRIPTION: The ***Kellogg's Family Rewards® - Jurassic World: Fallen Kingdom Movie Ticket Sweepstakes*** ("Sweepstakes") is a Daily Sweepstakes that begins at 12:00:00 AM (ET) on 4/24/18 and ends at 11:59:59 PM (ET) on 9/14/18 ("Promotion Period"). The Promotion Period will consist of a Mail-in Entry Period which begins on 4/24/18 and ends on 8/31/18 (the "Mail-in Entry Period"); and an Entry Period which begins at 12:00:00 AM (ET) on 5/1/18 and ends at 11:59:59 PM (ET) on 9/14/18 (the "Entry Period").
